ORGANIZER RECEIVES APPLICATION FORMS TILL **May 1, 2010**

Attention! All applications are considered by the Expert Council. After the Expert Council decision Organizer could reject the application.

1. After receiving an application form and Expert Council decision Organizer will send the 1 invoice (100% of space + registration fee, electric supply). The space is reserved only in case of 100% payment not later the date mentioned in the invoice.
2. For additional services Organizer send the additional invoice.
3. The full payment for the exhibition including all the additional services must be done upon the final invoice before **July 15, 2010**.
4. The organizer has the right to cancel the application form and to change the location of the booth if the payments are not settled on time.
5. Should, till **August 1, 2010**, the exhibitor inform Organizer that he will be not participating at the event; Organizer has the right not to return the percent on his own discretion. Should, after **August 1, 2010**, the exhibitor inform Organizer that he will be not participating at the event; Organizer has the right not to return the deposit which was transferred by the participant.
6. The contract should be set up till **September 5, 2010**.
